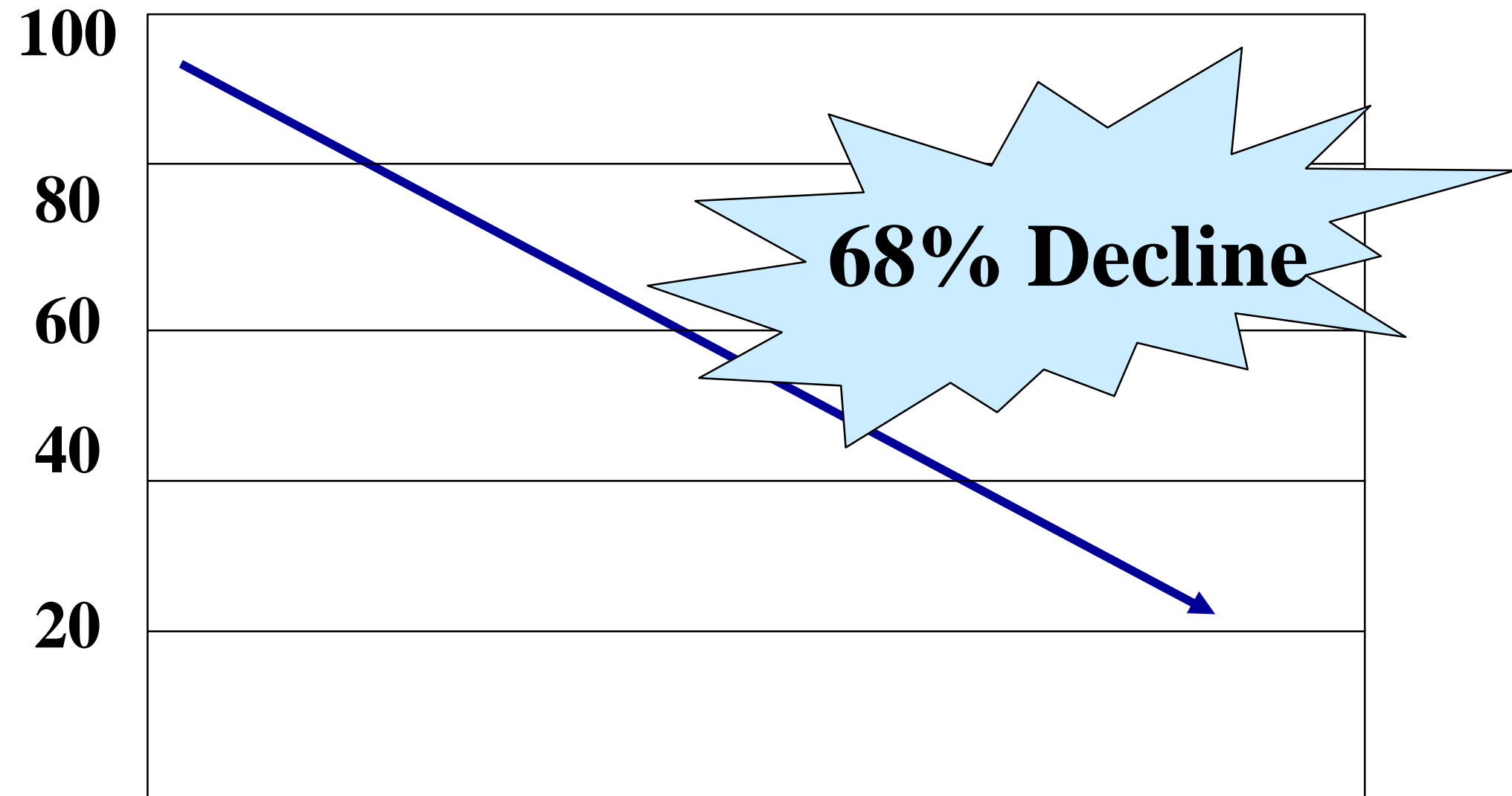

# Technology Transfer

## Key Mechanisms:

### **CRADA– Cooperative Research & Development Agreement**

- Federal labs may accept, retain, and use funds, personnel, services, and property from a collaborating party and provide personnel, services, and property to a collaborating party
- Property may include intellectual property, equipment and material
- Services may include the full spectrum of RDT&E support

### **TSA- Test Service Agreement**

- Federal labs are authorized, for an appropriate fee, to test materials, equipment, models, computer software, and other items for any person or entity.

# Technical Support for NIOSH/NIST

ECBC provides technical and testing support to the National Institute of Standards and Technology (NIST) and National Institute of Occupational Safety and Health (NIOSH)

## Chemical Point Detectors

- Draft standard expected early 2003.

## Respirator Standards Efforts

- Self-Contained Breathing Apparatus (SCBA) standard completed in 2001
- Air Purifying Respirator standard expected in early 2003
- Escape Hood standard expected in late 2003
- GB and HD Agent and Laboratory Respirator Protection Level (similar to PF) certification testing currently performed by ECBC for SCBAs.

## Personnel Protective Equipment (Suits/Ensembles) Standards

- Working with National Fire Protection Association to update their 1994 Standard, Protective Ensemble for Chemical/Biological Terrorism Incidents. In accordance with the NFPA revision cycle the draft standard will be available June 2003.
