

DPAP Directorates • DARS

- Implements statutes and mission focused policies, procedures and guidance in FAR, DFARS and PGI
- Policy
 - Focal point for developing new, innovative acquisition policies and improving existing DoD acquisition policies
- Program Acquisition and International Contracting
 - Responsible for DoD 5000 series policies and business strategies for acquisition programs and international contracting issues
- Program Development and Integration
 - Creates policies for uniquely identifying tangible items
 - Develops and implements strategies for purchase card

Our Mission

The Defense Acquisition Regulations System (DARS) develops and maintains acquisition rules and guidance to facilitate the Acquisition workforce as they acquire the goods and services DoD requires to ensure America's Warfighters' continued worldwide success.



Federal Acquisition Regulation (FAR)

- Regulations required by law and policy
- Rules apply to Federal government agencies
- Content determined by FAR Council
 - Office of Federal Procurement Policy (OFPP)
 - Department of Defense (DoD)
 - General Services Administration (GSA)
 - National Aeronautics and Space Administration (NASA)
- DPAP represents DoD on FAR Council



Defense Federal Acquisition Regulation Supplement (DFARS)

- Regulations required by law or policy
- Rules apply to DoD
- Content determined by DAR Council
 - Military Services
 - Defense Agencies
 - DAR Council Chair
- DARS leads and guides the DAR Council



Procedures, Guidance and Information (PGI)


- Internal DoD procedures
- Provides a central point for locating:
 - Agency guidance
 - Training
 - Guides
 - Outside resources
 - OSD policy letters
 - Other pertinent information
- Companion resource to the DFARS
- Single access-point to internal DoD acquisition procedures, policy training and class deviations

The Rulemaking Process







Federal Acquisition Regulation (FAR) Council

- Responsibilities:
 - Provide overall strategy to the DAR Council and CAAC
 - Resolve disagreements between the DAR Council and CAAC
- Members:
 - Administrator, Office of Federal Procurement Policy (OFPP)
 - Director, Defense Procurement and Acquisition Policy (DPAP), DoD
 - Deputy Chief Acquisition Officer, GSA
 - Deputy Chief Acquisition Officer, NASA



Defense Acquisition Regulation (DAR) Council

- Responsibilities:
 - Promulgate the DFARS and PGI
 - Promulgate the FAR (in conjunction with CAAC)
- Members:
 - Representatives from the Military Services and Defense Agencies
 - Representatives from NASA
 - DoD DAR Council Chair



Civilian Agency Acquisition Council (CAAC)

- CAAC Members:
 - Representatives from the Civilian Agencies
 - GSA CAAC Chair
- Responsibilities:
 - Promulgate the FAR (in conjunction with DARC)
 - Publish Federal Register (FR) notices, solicit public comments
 - Advance notice of proposed rulemaking (ANPR)
 - Proposed and interim rules
 - Publish Final rules in FR
 - Hold public meetings
 - Review all public comments and provide responses in FR
 - Reach agreement on FAR changes
