## **( w o r l d w i d e )**

- 💧 **Established long-term government-wide contracts (5 year base with three 5 year renewal options)**
- 💧 **Increases Federal business opportunities**
- 💧 **Drastically reduces procurement lead-times and administrative costs**
- 💧 **Direct relationship between the ordering agency (non-assisted contracting services) or GSA (assisted contracting services)**

1. **Search Schedules e-Library [www.gsa.gov/elibrary](http://www.gsa.gov/elibrary) by keyword to identify supplies or services covered by GSA Schedules**
2. **Click on the box, “Vendors: Click here to view the current solicitation on FedBizOpps”**
3. **Download the solicitation, read thoroughly and follow the instructions in the document**
4. **Register in the Central Contractor Registration**
5. **Obtain an Open Ratings Inc. reference check (see Past Performance Evaluation form in solicitation)**
6. **Complete all information in the solicitation and be ready to negotiate the company’s best offer**

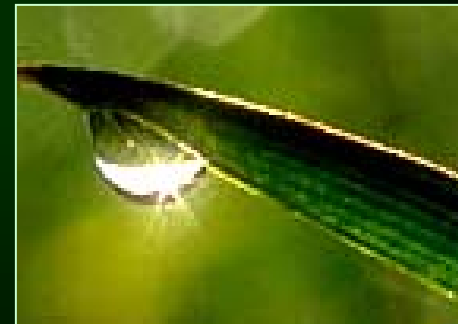

# F A R P A R T 36

**Construction and Architect-Engineering services as set forth in FAR Part 36 (including construction of buildings, structures, or altering other real property) are *outside* the Schedule scope.**

# THE BROOKS ACT - ARCHITECT - ENGINEER SERVICES

- 💧 If the agency's Statement of Work, substantially specifies performance or approval by:
  - (1) a registered or licensed Architect or Engineer
  - (2) for services *related to real property* the Brooks Act applies.
    - Such services must be procured in accordance with FAR Part 36
- 💧 Use of Brooks Act Architect-Engineering (A&E) services is NOT authorized on Schedule.

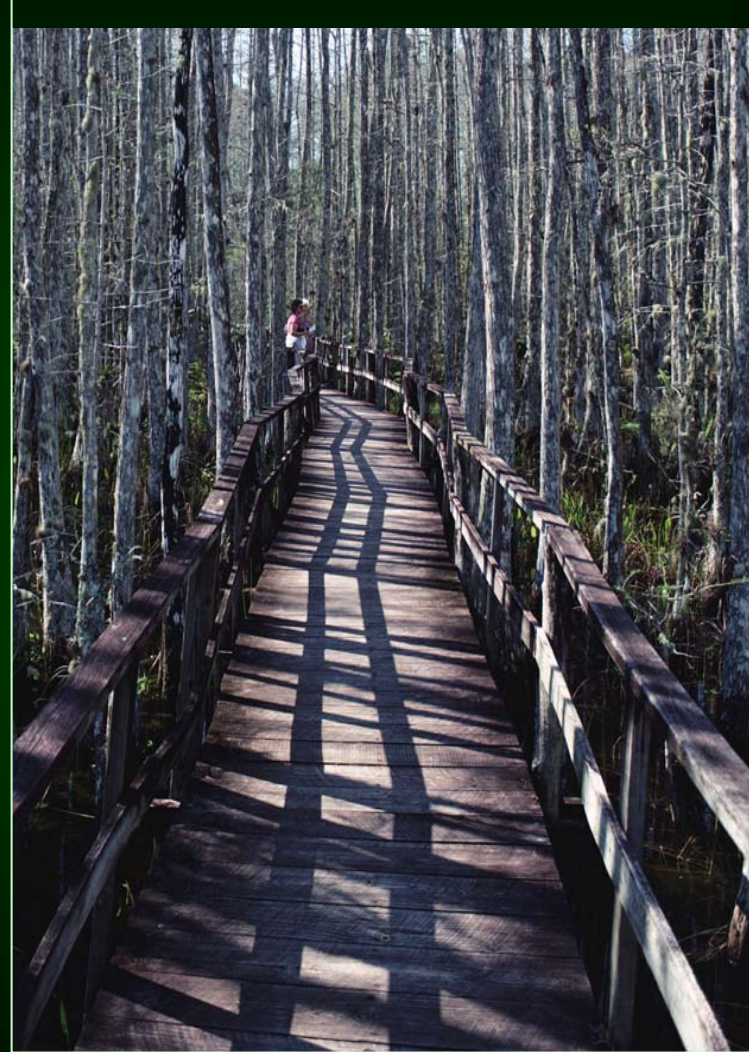

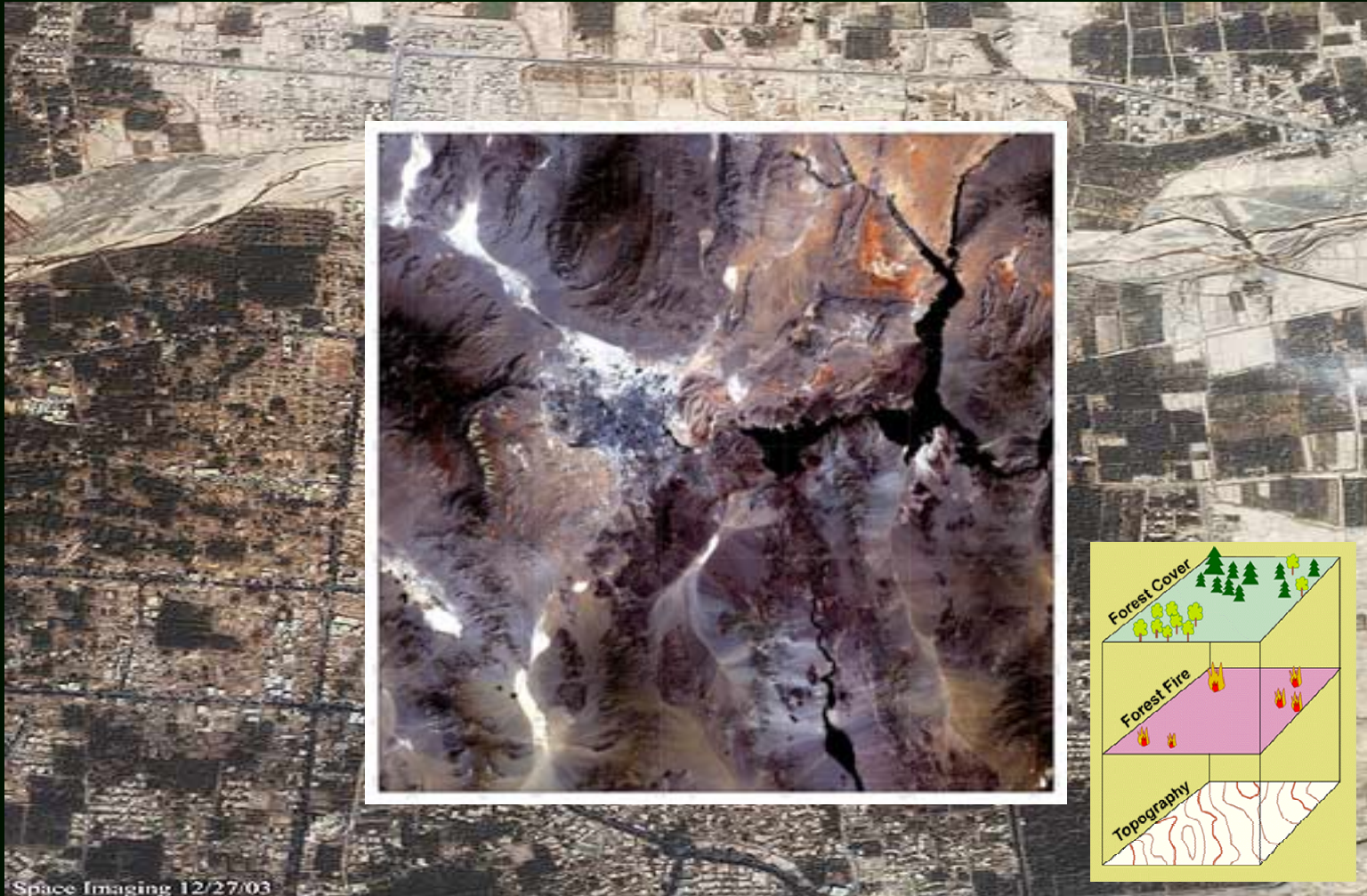

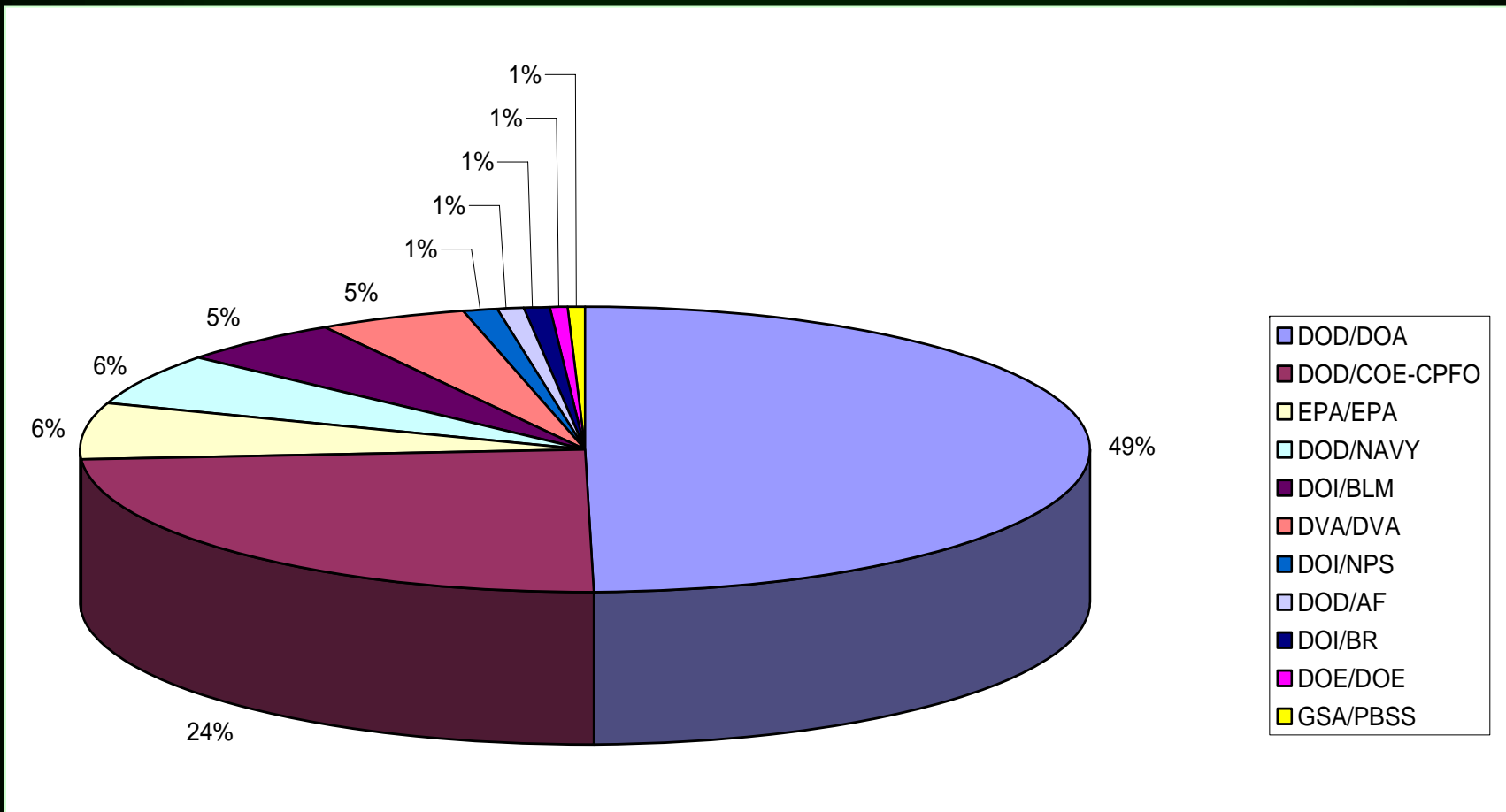
# INTRO. OF NEW SERVICES

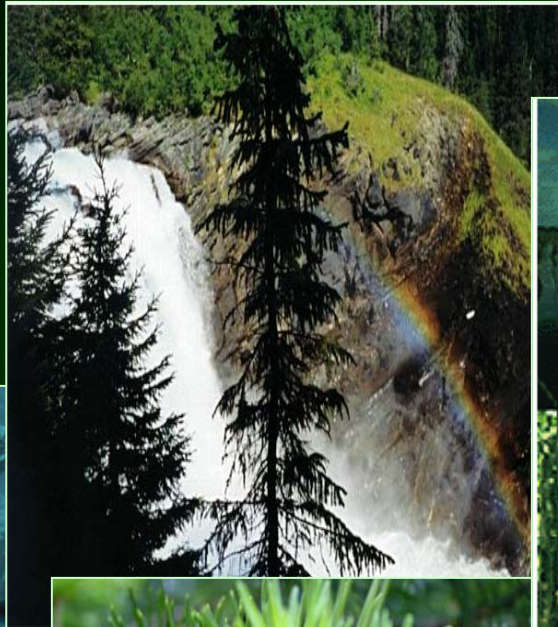
