PMI/CPM initiated suggestion

- On 23 January 2003 Eleanor Haupt (PMI/CPM President) suggested that NDIA and CPM initiate *collaboration* on certain EVM documents
- She envisions this as part of a long term strategy with several national and international associations
- She would also like to enhance the PMI/CPM website
- She plans to take her recommendations to the PMI/CPM board on 1 March

PMI/CPM initiated suggestion

- She suggested that NDIA take ownership and sponsorship of certain EVM documents
 - Co-ownership/Co-sponsorship might be a better definition from time to time
 - The OTB/OTS Handbook would be first
 - Other EVM documents would be considered

 - Identify a strategy/framework for moving forward together
 - Identify Joint PMSS/CPM work team
 - Joint team make handbook issue(s) recommendations to PMSS body
 - Move OTB document forward similar to proposed EVM Guides under Sub-Team development
